




Historic Preservation: 2006 Plan

2006 Historic Preservation Plan




- General campus-wide assessment of buildings and the history of the UA built environment through 2006 (architecture & landscape)
- Recommendations and guidelines primarily focused on Pre-1937 building inventory (Historic District and contributing area), but does advises 1958 as the historic cut-off at that point in time.
- Acknowledgement that "the" topic in the coming decades will be establishing a view on the large number of modernist buildings




Landscape Features






Modern-Era Buildings Under Consideration (1950-1970)

"Transitional" (Shift into Modernism) Examples:

Art Building & Museum (1957)

Characteristics: Demonstrate transition of architectural thought, hybrid of the "old" and "new" – same components but expressed in a more simple way, larger sections of glazing

"Academic Eclectic" Examples:





Coconino Hall (1954) Biological Sciences
East
(1957)

Characteristics: Strong symmetry, Spanish tile roofs, red brick, often incorporate classical elements, do not strongly conform to traditional characteristics of modernism but do incorporate material elements of the time

"International Style" Examples:







Physics & Atmospheric Science (1960)

UA Global Center (1964)

Babcock Complex (1967)

Characteristics: Defined by volumetric overlaps and composition as opposed to ornamentation, cantilevered elements act as vanishing points, utilization and expression of concrete, glass, and steel

"Late Modern" Examples:







Admin Building (1966)

College of Law (1969) Main Library (1976)

Characteristics: Typically have less windows than traditional or early modern counterparts, increase in façade elements to mimic classical elements in geometric ways (such as tall piers or large screens), multiple styles distinct styles including brutalist examples, often (originally) detached from site elements



